1. **Originality is Mandatory:** All audio must be 100% original. No part of the composition may resemble or replicate existing musical works.
2. **No Use of Viral/Third-Party Content:** Audio or samples sourced from Instagram trends, reels, or any other viral content platforms are strictly prohibited.
3. **No Additional Dialogue or Laugh Tracks:** Songs must not include unnecessary dialogue, background laughter, or comedic inserts unless they are integral to the original composition and approved.
4. **Strict Prohibition of Vulgarity:** Lyrics and artwork must be free from any vulgar, obscene, or offensive content. Content that promotes hate, violence, or explicit behavior is not allowed under any circumstances.
5. **No Personal Information:** Songs and artwork must not contain phone numbers, email addresses, or any form of personal contact details.
6. **Artwork Specifications:**
 - Must be clean, professional, and of high resolution.
 - Only essential credits are allowed: Singer, Lyricist, Music Composer / Producer.
 - Any additional branding or text must receive prior written approval.
7. **Illegal Activities & Penalty Clause:**
 - Any form of **illegal activity**, including but not limited to **artificial streaming, fraud, or unauthorized use of content**, will result in an immediate **penalty of \$5,000 USD** payable by the channel/content owner.
 - In such cases, **full ownership of the entire content catalog** associated with the channel will be **transferred to the distributor** without further notice, and all revenues will be withheld until the penalty is cleared.

Network Participation Terms - HarDan Music Group

1. **Minimum Revenue Requirement:** Only channels generating a minimum of **\$400 USD per month** will be considered for network linkage.
2. **Unlinking Policy:**
 - **Minimum Commitment:** Channel owners may request to unlink from the network only **after completing a minimum of 12 months** from the official date of joining.
 - **Notice Period Requirement:** A formal unlinking request must be submitted with **at least 60 working days' prior notice**. This notice must be in writing and sent through the official communication channel designated by the network.
 - **Processing Timeline:** Upon receipt of the unlinking request, the unlinking and unlocking process may take **up to 30 working days** to be fully completed. During this period, the channel must remain fully compliant with all network guidelines and obligations.
 - **Pending Dues & Documentation:** All pending dues, paperwork, and contractual obligations must be cleared before the unlinking process can be finalized.
3. **Content Ownership & Originality:** Channels must **not host any reused, repurposed, or third-party content**. All content must be verifiably owned or licensed by the channel owner.
4. **Documentation Submission:**
 - Complete paperwork for all uploaded songs (including ownership declarations and rights clearances) **must be submitted within 90 days** of network linkage.
 - Failure to do so may result in revenue withholding or removal from the network.
5. **Copyright Compliance:**
 - If a **copyright infringement or strike** is detected, **100% of the channel's revenue will be placed on indefinite hold** until the issue is fully resolved.
 - Repeated offenses will result in **permanent removal from the network** and potential legal action.
